Foam, dry chemical, carbon dioxide (CO₂), water-spray.

5.2 Special hazards arising from the substance or mixture

Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Upon decomposition, this product emits carbon monoxide, carbon dioxide and/or low molecular weight hydrocarbons.

5.3 Advice for firefighters

Use breathing apparatus with independent air supply. Wear full protective suit when fighting fires involving chemicals. Use water spray to cool containers exposed to fire.

5.4 Additional information
