7.1 Precautions for safe handling.

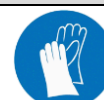

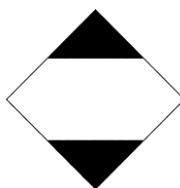

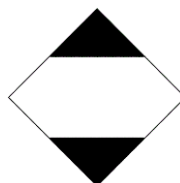
